**SPECIAL LICENSE FOR THE SALE OF WINE  
BY MASSACHUSETTS FARMER WINERY LICENSE HOLDER  
AT SANCTIONED AGRICULTURAL EVENT**

**Instructions**  
**(as of November 2021)**

1. First, the applicant must apply for a certification with the Massachusetts's Department of Agricultural Resources (MDAR) to certify that the proposed event is, in fact, an Agricultural Event. The application is available on this [website](#). The application must be emailed to [Katelyn.Rozenas@mass.gov](mailto:Katelyn.Rozenas@mass.gov). **Once the applicant is certified, the certification application and proof of certification letter must be submitted with this Licensing Board application at [LicensingBoard@boston.gov](mailto:LicensingBoard@boston.gov).**
2. The Applicant should then complete *this* Licensing Board application which must be signed-off by Boston Police Captain in the area where the Agricultural Event will take place. You can find which police station by entering the address of the venue here: [bit.ly/bpdlookup](https://bit.ly/bpdlookup).
3. The Licensing Board's application must be submitted to Licensing Board three (3) weeks prior to event for sufficient time to be voted on by the Licensing Board. Hearings are generally held the first and last week of the month.
4. If the license is granted, a fee of \$50.00 is due in order to pick up the license.
